GAME TIMES: Games will start on Saturday, November 19 at 8:00 A.M. depending on

the number of teams registered.

UNIFORMS: Same color jersey with non-duplicating numbers including at least an 6

inch number on the back. The number on the front is recommended but not mandatory. Any shorts or pants worn must not have pockets per TAAF

Cavalcade.

EQUIPMENT: Teams are expected to provide own footballs. TAAF will provide the flag

belts and will be required to use.

PROTEST: All protests must be filed by the end of the game. Only a coach can file a

protest. Judgment calls are not a basis for protests. You must notify the officials and scorekeeper so the protest is noted in the book. Please complete a protest form and submit with \$50 non-refundable fee in cash. Protests will be reviewed by the Protest Committee and the ruling will be

final.
