The Texas Amateur Athletic Federation Scholarship is funded by contributions from public and private sectors. These funds are set up in the Texas Amateur Athletic Federation's Foundation. This scholarship is available in three categories. It is offered to Texas Amateur Athletic Federation athletes, both past and present; parks and recreation employees; and high school and/or college students seeking undergraduate or post graduate degrees in the field of sports sciences, kinesiology, conservation, physical education, recreation and tourism management and/or other related courses of study which may contribute to the field of parks and recreation. A description of each category to be awarded is listed below.

The application and all requested documentation under the scholarship category for which you are applying are due to the T.A.A.F. State Office via email (ginger@taaf.com) by March 31st of each year. Announcement of selected individuals will be made at the Texas Amateur Athletic Federation Mid-Year meeting in April/May each year, for the upcoming fall, spring and summer semesters. Dan Whitworth Memorial Student Scholarships

Educational assistance available to graduating high school students or college students who are pursuing degree programs in the field of sports sciences, kinesiology, conservation, physical education, recreation and tourism management and/or other related courses of study which may contribute to the field of parks and recreation with the intent to enter the recreation, parks and leisure service field as a career.

Eligibility Requirements:

Graduating High School Student/High School Graduate:

- Acceptance to an accredited college or university. Enrollment for a minimum of 12 hours will be required. Preference will be given to those applicants attending a Texas college or university.
- Has a high school class ranking of at least the top quarter or a 2.5 GPA on a 4.0 scale or a minimum of 850-SAT, minimum score of 21 on ACT.

College or University Student:

• Currently enrolled at a college or university in an accredited Bachelors, Masters or Doctoral degree program in the field of sports sciences, kinesiology, conservation, physical education, recreation and tourism management and/or other related courses of study which may contribute to the field of parks and recreation. Preference will be given to those applicants attending a Texas college or university.

- Maintain a minimum of 12 hours per semester or graduate students must be enrolled full-time.
- Must possess a GPA of at least 2.5 on a 4.0 scale or pass on a pass/fail system from the previous semester.

Selection Process

Applications will be reviewed for eligibility and considered on the basis of the following criteria:

- Honors and awards from, and participation in: activities, endeavors, volunteerism and work, etc. related to athletics and/or the field of parks and recreation
- SAT or ACT score
- Grade point average
- Submittal of all requested documentation
- Other objective related criteria determined by the selection committee

Athlete Category

Educational assistance is available to a past or present Texas Amateur Athletic Federation athlete, seeking an undergraduate or graduate degree, at an accredited college or university, and in an accredited degree program.

Eligibility Requirements

- Must have competed in one or more Texas Amateur Athletic Federation state level competitions or state tournaments.
- Acceptance to an accredited college or university. Enrollment for a minimum of 12 hours will be required. Preference will be given to those applicants attending a Texas college or university.
- Or, currently enrolled at a college or university in an accredited degree program. Preference will be given to those applicants attending a Texas college or university.
- Must possess a GPA of 2.5 on a 4.0 scale or a pass on a pass/fail system.
- Maintain a minimum of 12 hours per semester or graduate students must be enrolled full-time.

Selection Process

Applications will be reviewed for eligibility and considered on the basis of the following criteria:

- Honors and awards from, and participation in, activities, endeavors, volunteerism and work related to athletics and/or the field of parks and recreation
- Submittal of all requested documentation
- Other objective related criteria determined by the selection committee

Employee Category

Educational assistance is available for part-time and/or full-time employees currently working in the parks and recreation field, whose **current employer** does not provide any continuing education or tuition funding and **is a current T.A.A.F. Member City**. Assistance is to be used for Bachelors, Masters and/or Doctoral degrees that may qualify them for future job enhancements and opportunities.

Eligibility Requirements

- Currently a regular, part-time and/or full-time employee working a minimum of 15 hours per week with at least 6 months of continuous service at one or more Member Cities at time of application.
- Must be demonstrating satisfactory work performance.
- Must not have received a formal disciplinary action in the preceding 6 months prior to the application submittal.
- Currently enrolled at a college or university in an accredited Bachelors, Masters or Doctoral degree program. Preference will be given to those applicants attending a Texas college or university and those seeking a degree in parks, recreation and tourism sciences, sports sciences / leisure services, public administration or related field.
- Must possess a GPA of 2.5 on a 4.0 scale or a pass on a pass/fail system.
- Must not be employed by an entity that currently provides full tuition reimbursement.
- Maintain a minimum of 6 hours per semester or graduate students must be enrolled full-time.
- If not currently enrolled at a college or university, you may also apply for tuition to attend an accredited professional development training to obtain an industry relevant certification credential (CPO, ASO, CYSA, CPSI, etc).

Selection Process

Applications will be reviewed for eligibility and considered on the basis of the following criteria:

- Will the educational goal relate to a field in the parks and recreation profession?
- What contributions will the educational course or certification provide to the parks and recreation profession?
- Submittal of all requested documentation.
- Other objective related criteria determined by the selection committee.

I'm honored for the opportunity to apply for the Dan Whitworth Memorial Student Scholarship. If awarded the scholarship, I will live up to the legacy of Dan Whitworth, a man who was the Director of the Parks and Recreation Department for the City of Corpus Christi for over 20 years.

Throughout my academic and professional career, I have actively engaged in various volunteer opportunities and leadership roles that have enriched my personal and professional development. Below are some of the highlights of my experiences:

1. Volunteer at the Houston Arboretum (2001 - 2004)

Between 2001 and 2004, I dedicated my time to volunteering at the Houston Arboretum. During this period, I gained invaluable knowledge about plant conservation and Texas indigenous plant species. This experience deepened my appreciation for environmental stewardship and community engagement.

2. **Dean's List Recognition (2004 - 2007)**

Throughout my academic career from 2004 to 2007, I consistently made the Dean's List, demonstrating my commitment to academic excellence and my ability to balance rigorous coursework with extracurricular activities.

3. Fulbright Scholarship (2007)

In 2007, I was honored to receive a Fulbright Scholarship, which allowed me to travel to India

to study Indian sports, yoga, and language. This transformative experience not only enhanced my cultural understanding but also solidified my commitment to global engagement. The scholarship is listed on my transcripts as Truman State University.

4. Certificate in Community Health (2013)

In 2013, I earned a certificate in community health, which provided me with a comprehensive understanding of community needs and health disparities. This knowledge has been instrumental in my efforts to contribute meaningfully to community service initiatives.

5. Content Engagement Achievements (2015 - Present)

Since 2015, I have been consistently recognized for my writing and content creation, achieving an engagement rate that garners 15% greater interaction each month. This accomplishment reflects my ability to connect with diverse audiences and contribute positively to my organization.

6. Admission to First Choice University (2025)

Looking forward, I have been granted entry into my first-choice university in 2025. This opportunity represents the culmination of my hard work, dedication, and commitment to my academic and professional goals.

These experiences have not only shaped my skills and knowledge but have also instilled in me a strong sense of purpose and a desire to make a positive impact in my community and beyond.

2. Please list your chosen or anticipated field of study and explain why you believe the field is important.

I was accepted into Sul Ross's MAg of Natural Resource Conservation (NRM) in Alpine, Texas. A master's in NRM will allow me to produce works that benefit both the people of Texas and the land we call home. For this reason, it's of the greatest importance.

I feel that working with the Alpine Parks and Recreation, Texas Parks and Wildlife Division (TPWD), or the Bureau of Land Management (BLM) to preserve heritage sites, both ecologically and culturally, as well as promote athleticism in parks and recreation facilities, is of the utmost importance. To do so, I will research the effects of tumbleweeds, *Salsoa*, on the ecology of the Trans-Pecos region, work towards developing a sustainable athletic turf, and strive for the inclusion of indigenous populations in athletics. As noted, I will live up to the legacy of Dan Whitworth, as well as uphold the principles set forth in the Great American Outdoors Act (GAOA), continuing to encourage federal and state entities to provide funding for leisure and recreational facilities. To me, obtaining an education and striving for a future in which parks and recreation continue to provide opportunities to participate in sports and interact with nature are paramount.

Ever since embarking on obtaining an education, I've planned to work with what I believe to be one of America's loftier public works, parks and recreation. I envisioned myself planning and facilitating all aspects of multidimensional recreational areas, parks that preserve the past just as well as they fit into the modern world. Without the MAg, none of this would be possible, moreover, without the GAOA, none of this would be possible. In sum, it's the field of NRM that maintains public lands for athletic pursuits, preserves heritage sites, and, through the Bureau of Indian Education (BIE), ensures a free education for our native population. These activities are of supreme importance.

3. How does Parks and Recreation have an impact on a community?

Parks and recreation plays a vital role in shaping and enhancing community well-being, particularly through initiatives focused on habitat restoration and biodiversity. In fact, parks and recreation not

merely provide leisure opportunists, they devise projects aimed at recovering native plant species. For instance, Lost Maples State Natural Area not only acts as a steward for Texas's few remaining maple trees, rangers lead outreach programs that enlighten visitors on the local flora and fauna.

Moreover, parks and recreation initiatives can create opportunities for collaboration with indigenous groups, recognizing their traditional ecological knowledge and fostering inclusivity. For example:

Co-management agreements develop frameworks that allow Indigenous groups to share decision-making authority over lands and resources.

Cultural Heritage Recognition integrate indigenous cultural heritage into park narratives and educational programs.

Traditional Ecological Knowledge (TEK) actively incorporates indigenous ways of knowing into park management strategies.

Above are merely a few of the ways in which parks and recreation positively impacts communities.

Often, parks and recreation serves as a bridge between young athletes and conservation initiatives, fostering a sense of stewardship among the youth, giving young people the tools and opportunities to engage in both physical activities and environmental stewardship. For instance, a park where I attended grade school curated the Mud Walk, a hands-on study of wetland ecosystems. In all, parks and recreation is responsible for much more than badminton courts.

How has it impacted you personally?

Parks and recreation have profoundly shaped my life. Interestingly, I've gained significant insights about life and history through my experiences in parks. It was at Sweetwater Park in Oviedo, Florida, where I first became aware of the painful realities of segregation and desegregation, which also ignited my passion for archaeology. There was a piece of folklore circulating that Sweetwater Park once

featured a swimming pool that was filled in by bulldozers after an African American individual went for a swim. Although the story wasn't accurate, it was inspired by the true story of David Isom, an activist from Clearwater, hearing it motivated me to grab a shovel and start excavating the site in search of archaeological evidence related to the struggle for equality or remnants of the pool. During my dig, I uncovered blue tiles but never determined whether they were indeed from a pool, along with another intriguing find: a musket ball.

Moreover, I first heard of the concept of a hermit at Hermit Park in Altamonte Springs, also in Florida. It's there that I first encountered the legend of a hermit who had made the park his home. This man, cloaked in mystery, chose a life of solitude among the lush greenery, and his story captivated my imagination. His house was surrounded by empty cans. The cans acted to alarm him of trespassers. The house has since been torn down. parks and recreation acts as a vessel for the legends and scientific discoveries that parks contain.

In addition to the above experiences, Red Bug Lake Park in Casselberry, Florida, offered me practical learning opportunities that enriched my understanding of sports and nature. It was here that I discovered racquetball. Additionally, while exploring the park's natural surroundings, I became fascinated by the diverse native insect populations that thrived in the area. Observing these small creatures sparked my curiosity about ecosystems and the vital roles they play, further deepening my appreciation for the interconnectedness of life.

4. If awarded this scholarship, how would you utilize your educational experience to make an impact on the parks and recreation / leisure services profession in your community or society as a whole?

I am particularly interested in researching species of athletic turf that require less water and fewer chemicals while providing a durable playing surface. Moreover, I will focus on the ecological challenges related to athletic turf presented by the Trans-Pecos region. This region faces distinct environmental pressures, including water scarcity, habitat fragmentation, and invasive species of tumbleweed. It's of undeniable import that we eradicate non-native plants such as the tumbleweed. By concentrating my initiatives within the Trans-Pecos, I aim to foster a culture of conservation and athleticism within the region.

I am committed to addressing several critical issues in athletic turf management that are unique to the Trans-Pecos region. This includes working with efficient water management, developing drought-resistant turfgrass varieties, improving soil quality, implementing advanced irrigation systems, and proactive pest and weed management. In my career, I will prioritize erosion control measures and the integration of native plants into sporting and recreational areas. I believe that an increase in the amount of athletic opportunities, through durable and sustainable athletic turf, promotes not just a sense of regional pride but also personal character traits that last a lifetime.

5. Explain your career goals upon graduation.

My goal is to collaborate with parks and recreation, whether that be the BLM, TPWD, or the city, and local sports organizations in the trans-Pecos region to develop and implement sustainable athletic turf. By promoting the use of sustainable turf, I can contribute to both environmental conservation and promote athleticism.

Furthermore, I plan to work towards getting more indigenous peoples of the trans-Pecos region involved in athletics. Regrettably, the indigenous populations in the Trans-Pecos are often underrepresented in sports. Engaging indigenous youth in sports not only promotes physical health but also empowers them to become stewards of their ancestral lands.

Within the region, limited access to athletic turf has created barriers for youth, hindering their ability to engage in physical activity and develop essential life skills through teamwork and competition. The lack of such opportunities not only affects the health and well-being of these young individuals but also diminishes their connection to the unique landscapes and natural resources that surround them. My goal of promoting sustainable athletic turf, through parks and recreation, is one step towards a greener and healthier tomorrow.

Moreover, despite its ecological richness, the Trans-Pecos region faces significant challenges regarding sports opportunities for both indigenous and non-indigenous populations alike. The region spans 31,000 square miles, yet most opportunities for amateur athleticism are restricted to El Paso. I aim to work towards broadening the scope of public funds and campaign for spaces for athletic endeavors in the trans-Pecos region.

Finally, in line with the mission of TAAF, which emphasizes the development of amateur athletics while promoting values of teamwork, sportsmanship, and community engagement, I aim to connect young athletes with conservation efforts, and ultimately build a stronger, more resilient community by addressing the challenges of limited sports opportunities.

6. Are there any other factors you would like us to consider in evaluating your application?

I am returning to school after a long hiatus, nearly 20 years. As an older student, returning to school at 45, I bring a wealth of life experience and determination to my studies. I am highly committed to completing my education. The Dan Whitworth Memorial Student Scholarship would significantly help in taking this giant step forward.



I would like to mention that I have not taken the SAT or ACT. Nevertheless, I successfully completed a Bachelor's degree in Anthropology from the University of North Texas, which reflects my dedication to my education and my ability to excel outside of standardized testing. I sincerely hope that my lack of standardized test scores will not hinder my eligibility for this scholarship, especially since I'm not applying on the basis of being an undergraduate student.

Moreover, as a person living with congenital nystagmus, a condition that causes my eyes to shift from side to side, and low vision, I have encountered unique challenges throughout my academic journey. These experiences have only strengthened my resolve to succeed. Currently, I am in my first semester of pursuing a Master of Agriculture (MAg) degree, with the goal of advancing my knowledge and skills in NRM. I will be enrolled full time. My undergraduate GPA was 3.15. My ambition is to make a positive impact on the future of sportsmanship in America as I transition my career from copywriting to a field that aligns with my passions and values. I am truly excited about this new chapter in my life and eager to contribute meaningfully to NRM. One final thought on this, I feel that my background in writing will assist with community engagement, an essential aspect of parks and recreation.

Additionally, I would like to share a personal narrative.

The Significance of Athletic Turf

To me, the significance of athletic turf transcends mere aesthetics, it symbolizes the spirit of teamwork and our American sports culture. Athletic turf serves as the sacred ground where dreams are realized and memories are forged. For a future that includes baseball diamonds and putting greens, we must strive for a sustainable future. In all of my works, I plan to do just that.

Conclusion

A Master's of Agriculture in NRM will serve as a vital tool in my quest to further the objectives of the GAOA, align with the mission of the TPWD and BLM, and contribute to the development of sustainable athletic turf so that I may further the mission of the TAAF, supporting amateur athletics.

With a commitment to education, collaboration, and innovative practices, I am dedicated to becoming a steward of our natural resources.
